

FEE REGULATIONS FOR 2020-2021

**ALL GUARDIANS ARE ADVISED TO PAY FEES BY ONLINE MODE ONLY THROUGH
E-CARE PANEL OF FRANCISAN SOLUTIONS PVT.LTD.**

1. **ANNUAL FEES** for all classes **Nursery - Class XII** : **Rs. 2750/-** must be paid by the **10th of April, 2020. No extension will be given.**
2. Fees of **April to December 2020** must be paid between the **1st and 10th** of each month.
3. Fees paid after the **10th of the month** for which they are due will be fined **Rs. 100/- (Rupees One Hundred only)** per month.
4. **Quarterly Fees** for **January – March, 2021** must be paid together by the 15th January, 2021. **No extension will be given.**
5. Admission Fees for **Nursery - Class X** : **Rs. 30,000/-**
6. Admission Fees for **Class XI** : **Rs. 26,000/-**
